PRESIDENT'S LETTER

FLYING FRIENDLY – THE IMPORTANCE OF NOISE ABATEMENT

Good news! Aviation business is picking up at KCCR. Fuel is becoming cheaper, we are flying more, and of course training activity is booming at both PSA and Sterling. The EDIP (Economic Development Incentive Plan) program is being implemented, which should also lead to more activity.

Of course, with the good news comes some bad news. In 2015 noise complaints increased 91 percent over 2014. By location, the largest increases came from Martinez (up 217%) and Concord (up 188%). By type, both the largest number and the largest increase were for propeller aircraft (up 140%), followed by jet (up 67%) and helicopter (up 21%). Clearly we all have some work to do.

AOPA, CalPilots, and other aviation advocacy groups agree that noise management is the single most important factor in maintaining positive relationships with the surrounding community. Pointing out that the "airport was here first" does more harm than good. Progress comes from having a noise management plan, making sure all we pilots know about it, and then all of us following it, consistent with safe operation.

Fortunately, KCCR has a well-designed noise abatement procedure that is easy to follow and that presents minimal inconvenience for pilots. It can be downloaded here: <http://www.cccounty.us/3804/Buchanan-Field-Noise-Program> Printed copies are also available at the airport office, the FBOs and at MDPA meetings.

Studying the statistics and patterns, it's pretty clear that much of the increase has come from primary students doing pattern work. Airport management and MDPA are reaching out to instructors and students to make sure they all know about the

proper procedures.

But by no means is this all the fault of students. When I studied the KCCR Noise Abatement Procedures, I was chagrined to realize that I have been one of the culprits! For many years it's been my practice to begin my crosswind turn at 600 ft AGL. For a 19R departure this puts me right in the zone of maximum noise complaints, and at the altitude and power setting to cause the most noise. Of course, I did not do this intentionally. I always intended to be considerate of neighbors, but I soldiered on for years without studying the procedures. Now that I am familiar with the procedures I have slightly modified my technique with exactly zero inconvenience or expense.

In closing, here's another bit of good news. In both 2014 and 2015 there were exactly ZERO noise complaints associated with Byron! Of course it's impossible to do any better than zero! The residential areas around Byron are developing rapidly. Soon we will have a noise problem there too. It will be up to all of us to maintain the positive situation as the surrounding communities grow.

ADMINISTRATIVE ITEMS

MDPA President's Comments

President Maurice Gunderson reminded the pilots of the regularly scheduled Airport Advisory Committee meeting and encouraged pilots to attend. He introduced new member DeWitt Hodge who will head an initiative to more formalize the Historical Aircraft display each month. Also introduced was the Airport Manager, Keith Freitas, who mentioned a new air service, "JetSuite," being considered, namely a "scheduled charter service" to outside areas such as San Diego using the Brazilian Embraer passenger aircraft. He also introduced Dominic Aliano, the Representative from the office of Karen Mitchoff, Supervisor for District IV, Contra Costa County. Buchanan Field is located in District IV. We very much appreciate Dominic's frequent attendance and support.

MDPA Treasurer's Remarks

Treasurer Elaine Yeary alerted everyone that dues are due for 2016. She reported the club's account funds on hand and described that we are a Non-Profit but not a "501.c.3 Charity".

John Barrella reported that the year's schedule had been posted on the club's website. The fly-out was cancelled due to the weather.

SAFETY FORUM

Moderator - Bob Tucknott

Bob's opening comment was about how much he appreciated the coming advent the national ADS-B system. He followed up by describing a close encounter, unintended, with a C5 out of Travis, while he was en route with 4 onboard to Lake Tahoe out the Bay Area. He described how his rear seat non-pilot passenger alerted him to the threatening approach of a jumbo military aircraft climbing towards his aircraft. His immediate reaction upon sighting the C5 was to climb and then to bank away sharply to open distance. He was caught in the vortex effect and flipped over. After recovery his discussion with Travis Approach confirmed that the controller team had missed the potential collision paths of the straight and level Cessna and the rapidly climbing C5. Post event discussions from all parties, primarily the FAA and USAF, revealed an Air Force flight crew absorbed in an IFR departure (probably looking at charts). It was clearly a case of that crew ignoring the "see and be seen" pilot criteria."

Comment by the Head Moderator:

I was mesmerized by the story and failed to get Bob to go back and address what preparation activities he might have included for the pre-flight that would have given him a head's up on potential "heavies" operating out of Travis, which was not far from his intended track. (Even simply looking at the runways at Travis for aircraft taking off can often provide an alert.)

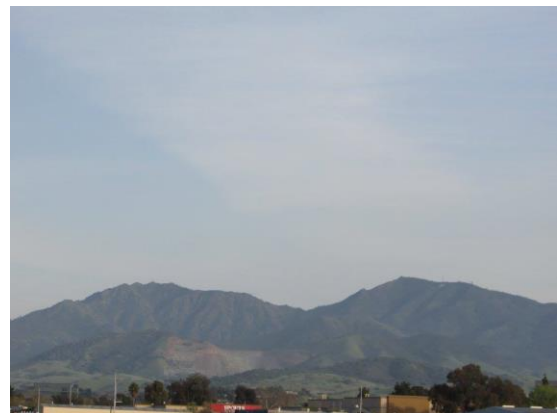
